

The regular meeting of the Council of the City of Norwich was held May 6, 2019, at 7:30 PM in Council Chambers. Present: Mayor Nystrom, Ald. Nash, Gould, Philbrick, DeLucia, Browning and Burnham. City Manager Salomone and Corporation Counsel Michael Driscoll were also in attendance. Mayor Nystrom presided.

Ald. DeLucia read the opening prayer and Ald. Gould led the members in the Pledge of Allegiance.

Upon a motion of President Pro Tem Nash, seconded by Ald. Gould, it was unanimously voted to adopt the minutes of April 1, 11 and 15, 2019.

I attended the monthly SCCOG, SEAT and Harbor Management meetings. I attended the Connecticut Conference of Municipalities meeting that was held at the Groton Town Hall for Municipal Unity Week. CCM CEO, Joseph DeLong and CCM Deputy Director, Ron Thomas gave an update of the key-state-local issues before legislators.

I met with department heads regarding the budget. Sharon Peccini, Sr. Vice President from United Way also attended the meeting and thanked the City employees for their continued support and donations. I also met with the Fire Chiefs regarding their apparatus inventory for the fire study.

I had the pleasure of attending the Annual Volunteer Recognition Breakfast that was held May 2nd, at the Senior Center. There were 132 senior volunteers that were recognized for their efforts. Thank you to those that volunteer and those who donated items and participated in this yearly event to make it a success.

The City is applying for a competitive Transportation Alternatives Program (TAP) Grant (2021) through the Southeastern Connecticut Council of Governments. The project, if awarded, will improve mobility along New London Turnpike from Norwichtown to Melrose Park Road in the vicinity of Three Rivers Community College by improving sidewalks, ADA accessibility, and providing almost 3 miles of bicycle facilities. The total project cost is \$982,800 with the City providing a 20% match for Construction + Design. I attended the presentation today at SCCOG.

Eight students from Teachers Global Studies Magnet Middle School had a tour of several City Departments on April 24th. City Clerk, Betsy Barrett led the tour with my assistant, Jacquie Barbarossa and the Mayor’s secretary, Bonnie Cuprak. The students visited the Clerk’s Office,

Assessors, Finance and Treasurers Offices, City Manager's Office and Council Chambers. Department Heads gave a brief overview of their office functions and the students ended in Council Chambers where Mayor Nystrom, Alderwomen Stacy Gould and Joanne Philbrick answered questions and encouraged the students to take part in City government.

The City received several new pieces of professional artwork from artists from the China Artists Association as a cultural exchange and act of appreciation. Mayor Nystrom and Alderman Sam Browning received the art from the visiting artists who also visited Slater Museum and Norwich Free Academy as part of the tour.

Eleven youths from Norwich schools and organizations were recognized for their efforts on Friday, May 3rd in honor of National Youth Service Day in Council Chambers. Recipients were Bailey Buchan, John Coleman, Vivian Ha, Cameron Kurasz, Samira Burlingame McCord, Leopoldine Bertrand, Norine Andrade, Elsie Sperry, Eddie Cruz, Cami Hawkins, & Mykayla Guimond. Congratulations on your accomplishments. Angelo Callis from Norwich Youth and Family Services coordinated the event to honor the recipients.

Mayor Nystrom called for citizen comment.

Marvin Serruto, 100 Starr St., expressed his confusion of the order of resolutions #11 through #19.

H. Tucker Braddock, 868 Scotland Rd., spoke in support of #17 and is thankful for the support and is hopeful of it passing.

Gerry Martin, 19 Gillette Rd., spoke with gratitude of Resolution #10 and named all the departments and individuals support involved to make this happen in honor of his mother.

Dennis Slopak, 8 North Second Ave., spoke in support of Resolution #12 and fully funding the Board of Education.

Yvette Jacaruso, 192 Wightman Ave., spoke in support of Resolution #12 explaining the problems and pitfalls that the Board of Education has with the budget.

Mark Kulos, 327 Broadway, spoke in support Resolution #12 explaining the difference between wants and needs.

Janis Sawicki, 39 Andrea Lane, spoke in support of Resolution #12 she spoke of her frustration with the way the Board of Education budget is distributed. Volunteering her help to fix it.

Rodney Bowie, 62 Roosevelt Ave., referenced Resolution #12 and stated that any child who wants an education will get one regardless of the budget. He also mentioned a discussion he had many years ago about NPU being owned by the City in reference to Resolution #18 stating the most money that can be kept in the CCD he is in support of.

Derel Wilson, Second St., supports Resolution #12 and also expressed the need to pass Resolution #16 it is required and needed and long overdue we owe it to the children.

Rick DiGiacomo, 8 Turnpike Park, spoke in support Resolution #16 as President of the Norwich Youth Football league. He expressed the problems and violations that the league has faced in the past and looking for the passage of the resolution.

Dave Wollman, Clinton, CT, spoke in support of Resolution #16 as an owner of a landscaping business he has volunteered his time and service to the betterment of this field and feels irrigation is going to be a tremendous help.

Mayor Nystrom declared citizen comment closed.

WHEREAS, said festivals are listed as follows, the schedule including the time of the closure of Franklin Street to vehicle or traffic:

- 1) Saturday, May 18, 2019 Haitian Flag Day, a flag raising ceremony at City Hall at 12:30 pm, a procession at 1:00 pm, and the festival to run from 2:00 pm – 6:00 pm with the closure of Bath St. from noon until 7:00 pm;
- 2) Saturday, May 25 and Sunday May 26, 2019 Cape Verdean Festival, a soccer tournament to be held on May 25th and a festival from 1:00-7:00 pm on Sunday, May 26, 2019 with street closure from 11:00 am-8:00 pm;
- 3) Saturday, June 15, 2019 Juneteenth Festival, festival from noon-6:00 pm with the closure of Bath St. from 10:00am-7:00pm;
- 4) Sunday, June 23, 2019 Polish Festival, festival from 2:00 pm-6:00 pm, with street closure from noon-7:00 pm;
- 5) Sunday, July 28, 2019 Peruvian Festival, festival from noon-6:00 pm, with street closure from 10:00 am-7:00 pm;
- 6) Sunday, August 11, 2019 Dominican Festival, festival from 2:00 pm-6:00 pm, with street closure from noon-7:00 pm;
- 7) Saturday, September 14 and Sunday September 15, 2019, Cup of Nations Soccer Tournament, with soccer tournament held Saturday, September 14, 2019, and festival Sunday, September 15, 2019 from 2:00 pm-6:00 pm, with street closure from noon-7:00 pm; and

WHEREAS, Global City Norwich will also be sponsoring the Ellis! Arts & History Festival to be held Sunday, August 18, 2019 from noon-6:00 pm at the Angelo Sanquedolce Plaza and at that David Ruggles Courtyard located in front of City Hall; and on Sunday, October 6, 2019 from noon-6:00 pm the International Food Festival on the Angelo Sanquedolce Plaza and the David Ruggles Courtyard in front of City Hall; and

WHEREAS, the Council of the City of Norwich by this resolution intends to grant permission for this use of Franklin Street and the Angelo Sanquedolce Plaza and the David Ruggles Courtyard as set out in this resolution, to express its support for these various Festivals, their organizers, supporters and sponsors, and to welcome each festival and the many visitors each will attract to downtown Norwich.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NORWICH, that the Council is in support of each of the proposed festivals, authorizes each making the request, to be held on Franklin Street with a vehicular or travel restrictions as listed herein in accordance with the recommendation that the Chief of Police as the traffic authority, or on the Angelo Sanquedolce Plaza and the David Ruggles Courtyard in front of City Hall as requested.

The amendments made to the City Manager's proposed budget in the tentatively adopted budget results in a 0.02 mill increase in the General Fund mill rate to 39.97 mills and no changes to the TCD mill rate of 0.36 mills nor the CCD mill rate of 7.67 mills.
