

**MOHEGAN PARK LAKESIDE PAVILION**  
**RULES & REGULATIONS**  
**Rentals from April 15 through October 15**

1. The consumption of beer and wine **in moderation** is permitted in the **pavilion area only**.
2. Beverages are not to be dispensed in glass containers.
3. **POSITIVELY NO PETS ALLOWED.**
4. **POSITIVELY NO SWIMMING ALLOWED EXCEPT IN DESIGNATED AREAS.**
5. Parking is available in the parking lot below the Concession Stand or in any other paved parking lot. No parking is allowed at the pavilion. The driveway leading to the pavilion may be used to drop off food and other picnic needs. No parking is allowed on the blacktopped road leading to the pavilion.
6. Music from musicians, DJ's or recordings will be permitted at a moderate level. Excessively loud music from musicians or recordings **WILL NOT** be permitted.
7. Gas grills **ONLY** may be brought and used at the pavilion. They are to be used **ONLY OUTSIDE** of the pavilion building and can be used on the deck area, if desired. However, ensure that when transporting the grill through the building all grease overflow containers are empty or enclosed so there will be no spillage anywhere in the pavilion and/or surrounding areas.
8. Burning in the fireplace is not allowed.
9. Users are responsible for reasonable cleanliness of the pavilion area, although City forces will thoroughly clean the area at the conclusion of the picnic. The City will provide refuse receptacles.
10. Participants in the group picnic must conduct themselves in an orderly manner. Those who do not abide by the rules and regulations will not be granted another permit to use the facility.
11. Permits will be issued to recognized organizations and family groups only. Tickets are not to be sold outside permitted group.
12. **The permit fee is not refundable should this reservation be cancelled, unless the pavilion can be rented to another group for the same day.**
13. Neither tickets nor refreshments may be sold at the permitted picnic.
14. The pavilion area **WILL BE OPENED AT 11:00 A.M.** and **CLOSED AT SUNSET**. Police are to take notice and will ask you to leave at sunset.
15. Nothing is to be brought into the pavilion such as: tents, tables, chairs, etc. Only that which is provided for you. Also no tables and chairs are to be removed from inside the pavilion. You may bring a gas grill through the pavilion for use on the deck area.
16. Posting of signs anywhere in Mohegan Park is strictly prohibited.
17. No egg tossing games allowed.
18. Pressurized string cans are **NOT** allowed.
19. Per Norwich Fire Marshall Code the maximum occupancy is 80 people.
20. **PUBLIC WORKS PERSONNEL HAVE THE RIGHT TO ENTER AND INSPECT THE PAVILION AT ANY TIME TO ENFORCE ALL RULES AND REGULATIONS.**
21. Renters will be responsible for pulling the window screens down, **leaving all trash bags inside** the building and for locking the pavilion doors.
